

**BRIGHTON & HOVE CITY COUNCIL
ROAD TRAFFIC REGULATION ACT 1984**

**Brighton & Hove Outer Areas (Waiting, Loading and Parking) and Cycle Lanes
Consolidation Order 2024 Amendment Order No.7 2026 (ref: TRO-12b-2026)**

Brighton & Hove City Council ("the Council") in exercise of its powers under sections 1(1), 2(1) to (3), 4, 45, 46, 49, 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the 1984 Act") as amended and of all other enabling powers after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order.

1. This Order may be cited as Brighton & Hove Outer Areas (Waiting, Loading and Parking) and Cycle Lanes Consolidation Order 2024 Amendment Order No.7 2026 and shall come into operation on the 3rd day of August 2026.
2. The Brighton & Hove Outer Areas (Waiting, Loading and Parking) and Cycle Lanes Consolidation Order 2024 is amended as follows:

ARTICLE AMENDMENTS:

PART 5 – SUSPENSIONS

Delete the following:

2. Upon receipt of any request to suspend the use of any Parking Place or any part thereof in accordance with Article 1 of this Part the Council may charge such amount in respect of the implementation of that suspension as is set out in Schedule 2 Part 1a.

And replace with:

2. Upon receipt of a request made in accordance with Article 1 of this Part to suspend the use of any Parking Place or part thereof, the Council may charge a fee for implementing that suspension, as set out in Schedule 2 Part 1a.

Where a parking bay is suspended otherwise than in accordance with the required application process, a **Non-Compliance Charge**, as set out in that Schedule, may apply to reflect the additional officer time required to regularise the suspension."
